- N.Young Introduced the Pair of ACES (Adverse Childhood Experiences & Adverse Community Environments) and the background of ACES.
- N.Young shared agenda of ACES training:
 - 1. How the Pair of ACES affects us all.
 - 2. How we can work together to build community resilience so that all children and families thrive.
 - 3. Tips and resources to build resilience starting with self.
 - 4. Group agreements introduced, respecting privacy of all participants.
- N.Young took a quick reaction survey of council participants regarding who are in different roles in child care. Council shared reactions.
- E.Guerrero introduced a grounding exercise, reflecting on current challenges. The group shared thoughts in the chat.
- N.Young went through an overview of the ACES with the tree and roots model.
- E.Guerrero introduced a group exercise, each creating a tree that reflects what we see within our community, the gaps in resources and societal beliefs.
 Group broke into breakout rooms for 10 minutes to discuss. Larger group reconveined. K.Lathrop, A.Renteria, M.Castro and P.Pastor shared what they discussed in their breakout groups.
- E.Guerrero led the group through a visualization exercise. The group shared thoughts in the chat. D.Munoz, K.Bobsin and J.Macecevic shared further thoughts.
- N.Young introduced slides and discussion of stress, well-being and health.
- E.Guerrero led the group through another exercise. The group went into breakout rooms again to discuss. Larger group returned after 15 minutes. M.Reilly, V.Boriack, K.Bobsin and J.Macecevic shared their small group findings.

It will be a mixed delivery child care system, including family child care providers and families with children involved in TK, soon to be called Pre-K.
