Stay home until no symptoms and no fever for 24 hours and negative Covid test from both parents (and all other adults in household) Covid testing for adults OR

Stay home until no fever for 24 hours and clearance from a doctor that the child is not contagious and symptoms are manageable (runny nose not going through the mask, child is able to keep mask on, and child well enough to participate in the activities)
