Cabrillo requires anyone "accessing" regular services (i.e. families coming daily to drop off/pick up children) are required to be vaccinated.

A child who has a positive exposure to a family member needs to stay home and test 5-7 days after the family member tested positive. If they test negative, then they can return. Most likely it'll be 10 days since their family member was tested positive. This is what I recently experienced with a student. They never got symptoms and ended up negative after a second test.
