 may shut down. They have between 5-9 children and families don't need care. Surveying families. WAWC, considering closing, will close one classroom that doesn't have enough teachers because of thanksgiving travel. They will close through mid-January. Biggest fear is families aren't telling the center what they are doing about travel. Bringing teachers to talk about it to keep staff safe. PVUSD centers are closed distance learning supporting teachers, family outreach and resource sharing. FCCs continue to serve children; providers are not leaving for Mexico this year. 250 children. There are 92 school age kids enrolled. ELCD will offer additional funding in January. Mental health support and staff. Program staff had COVID-19 in FCC homes. YWCA – in August a child was exposed to COVID – not sure when and they didn't have symptoms, so they quarantined for 14 days. So they closed the classroom staff and children. The classroom and children will return on Dec. 1st. They will start 2 days in person care and 2 days of distance learning sessions. 1 day for prep and conferences, family engagement. Surprised that all children returned to the center yesterday, December 1st. Encompass – following up with COVID vacancies exposures, quantities. They check in with staff regularly so they can respond to staff needs. Impacts testing prior to returning, closed 4 centers in the last week. Developing remote learning and at the center level. Families receiving distance learning are going well. Following health and safety protocols. May close and will 	
 conduct training to pre COVID – 19 Travel and Quarantine Policies: YWCA policy is that if staff travels they need to quarantine for 14 days and the staff don't get paid during this time. CB- will pay for quarantine time for staff. Not an easy thing. Continuity is important for both staff and families. Lisa it's more of a discussion and not a policy we can meet. Doesn't have a hold of their policies. Like to discuss the policies. Lorena, given what we know we could share the procedures would look like and give to staff. Lorena will send the COVID procedure framework. Cabrillo College – Lisa D will schedule a morning meeting. FCC are making their own policies and following protocols. Cabrillo College, Tricia semester was delayed a week, closing 12.18 put out an intent to return to center and have low enrollment for the spring. Will open in the 3rd 	

	week in January. Serving 4 Infants 8 Toddlers and 5 Prek. College has emergency leave act to provide reimbursement for staff that don't have sick pay yet. CDC changed from 14 to 10 day quarantine. LOSD: pre K teachers are setting up the classrooms so they will be ready. Finished DRDP conferences and provided packets for families, conferences went well and children are learning. It created a virtual community. PVUSD MHS – currently closed since Oct. offering distance learning and FCC are offering direct services. They are preparing for next year for supplies and materials for children.

IEEEP & Workforce Development Pathway Update CLASS – Framing Their Learning training 11.14.20 - follow up 58 QC staff members attended the training and QC programs received CLASS kits with Meghan's help. I sent the recordings and slides this morning. I. Sandra Ampudia, CLASS trainer from Florida will return for a check-in meeting with QC staff about CLASS implementation practices – Professional Learning Community in late January. Advisor Training - 11.17.20 - follow up – 23 early educators/stakeholders attended the Profess Growth Advisor training representing 9 different state/federally funded programs. IEEEP Grant – Beginning Together – collaborating with PVUSD to present required TOT community training on inclusive topics in January 2021. This inclusive TOT was recommended to IEEEP grant counties to offer IEEEP programs. I joined the Community Advisory Committee – North Co. SELPA in an attempt to begin to link with special Ed programs and a base to coordinate the IEEEP Leadership committee meeting in January 2021. The subcommittee that I joined is focusing on how to let families know about this framework and ask for it at the district and school levels. I'll share the UDL for Early Learning on the Padlet from the regional inclusion project. Linda O and Kathy are on the No. Co. SELPA Santa Cruz County Office of Ed. Virtual Library – One of the goals of the IEEEP grongrams via different modalities: in person, group zoom meetings and at the program level.
